Sri Adiningsih is the Head of Pusat Studi Asia Pasifik at Gadjah Mada University, Yogyakarta. She holds a Ph.D in Economics, University of Illinois, 1996 with a thesis titled "Optimal bank portfolio choice and Bank regulation: The Indonesian case." Her publications include: (coauthored with Dini N. Setiawati, and Sholihah) "Macroeconomic vulnerability in Indonesia," in *East Asian Development Network, Regional Project on Indicators and Analyses of Vulnerabilities to Economic crises* (Thailand Development Research Institute, 2003).

Dewi Fortuna Anwar is Deputy Chair for Social Sciences and Humanities at the Indonesian Institute of Sciences (LIPI). She is also Director for Program and Research at the Habibie Center in Jakarta and a member of the Board of Directors of the Center for Information and Development Studies. She obtained her PhD from Monash University, 1990 with a thesis titled "ASEAN as an aspect of Indonesian Foreign Policy." Her BA and MA were obtained from the School of Oriental and African Studies (SOAS), University of London in 1981 and 1982 respectively. She is the recipient of Distinguished Alumni Award from Monash University in 2008. Her main publications include: *Indonesia in ASEAN: Foreign Policy and Regionalism* (Singapore: ISEAS, 1994), *Indonesia at Large: Collected Writings on ASEAN, Foreign Policy, Security and Democratisation* (Jakarta: Habibie Center, 2005). She is currently Visiting Research Fellow at the CSEAS, Kyoto University.

Jusuf Anwar is the Ambassador of Indonesia to Japan. He served as the Minister of Finance under the Presidency of Susilo Bambang Yudhoyono (October 2004- December 2005). He was Executive Director of the Asian Development Bank (in Manila) representing Indonesia, New Zealand, the Republic of Kyrgyz, Samoa, Tonga, Fiji and the Cook Islands (2000-2004). He holds a Master degree in Economics from Vanderbilt University, and a Ph.D in Law, Padjadjaran University, Graduate School of Law.

Ibnu Hadi is the Consul General of Indonesia in Osaka. He obtained his BA in Economics, University of Indonesia, 1986 and Master degree in Economics, Macquarie University, Australia, 1990. He has joined the Indonesia's Ministry of Foreign Affairs since 1986 and served in Osaka as Consul for Economics in 1996-2000 and as Consul General in Osaka since January 2010. During his tenure as diplomat, he has been involved with economic issues, bilateral issues of trade, investment and technical cooperation, as well as regional cooperation including APEC.

Syamsuddin Haris is Head of Pusat Penelitian Politik at the Indonesian Institute of Sciences (LIPI). He holds a Master degree and Ph.D in Politics, University of Indonesia, and teaches at the Department of Politics, Universitas Nasional, Jakarta. Honna Jun is Professor at the Faculty of International Relations, Ritsumeikan University. He holds a Ph.D in Politics, Australian National University, 1999. Kano Hiroyoshi is Professor at Institute for Advanced Studies on Asia, Tokyo University. He holds a Doctorate degree in Economics, Tokyo University, 1990. Okamoto Masaaki is Associate Professor at the Center for Southeast Asian Studies, Kyoto University. He is interested in Southeast Asian local politics, especially Indonesia, and in the privatization of violence in Asia. Shiraishi Takashi has a Ph.D. in History, Cornell University in 1986 and taught at the University of Tokyo (1979-1987), Cornell University (1987-97), and Kyoto University (1996-2005). His main publications include: *An Age in Motion* (Cornell University Press, 1990, Ohira Masayoshi Asia Pacicfic Studies Award, available also in Indonesian with the title Zaman Bergerak), *Indonesia: Kokka to Seiji* (Government and Politics in Indonesia; Libroport, 1990, Suntory Academic Award), *Umi no Teikoku* (The Making of a Region; Chuokoron, 2000, Yomiuri-Yoshino Sakuzo Award), *Network Power: Japan and Asia* (Cornell University Press, 1997) and *Beyond Japan: The Dynamics of East Asian Regionalism* (Cornell University Press, 2006). He also serves as editor of *Indonesia* (Cornell University) and editor-in-chief of *Japan Echo*. He currently serves as executive member, Council for Science and Technology Policy and President, Institute of Developing Economies (IDE-JETRO).
